There is No Objection from Fire and Rescue Department with following conditions.

**CONDITIONS**

1. This License is Valid for One Year from date of issue.
2. Fire Safety Systems should be maintained in good conditions.
3. Mock drill to be conducted periodically with the help of local Fire Brigades.
4. Any erection of permanent or temporary structure should be intimated to this department.
5. A trained Fire Service Person, preferably retired one should be appointed.
6. Further to limit the occupant and to ensure better and life safety measures the following additional measures are insisted.
  - a. Building occupancy capacity should not be more than 4 people Per.Sq. Meter as per the National Building Code-2005
  - b. The staircase treads and flooring shall be treated with rough finish (grooving) to avoid falling.
  - c. As para 6.3 of the BIS standards IS 14435-1997 as the classroom have only one entrance, the capacity of the class rooms shall have to limited to 45 students.
  - d. Periodical maintenance and care should be taken to maintain all fire protection equipments.
  - e. Mock drill has to be conducted at regular intervals in consultation with the District Officer, Fire and Rescue Services, Chennai City Central District at Kilpauk.
